## **Oversigt over CEMS og de akademiske medlemmers institutionelle indlejring**

**London School of Economics and Political Science** er en selvstændig institution, der dækker det fulde spektrum inden for samfundsvidenskaberne, incl. Business Studies, men også med en betydeligt islæt af humaniora. LSE er organiseret i 19 *departments* samt et antal tværdisciplinære *institutes*.

**Stockholm School of Economics** er en selvstændig business school, der fokuserer på de klassiske (dvs overvejende social science based) business school discipliner, organiseret i 9 *departments* og en række *research centres*.

**Norwegian School of Economics and Business Administration** er en selvstændig, business school, organiseret i 5 *departments* (klassiske business school discipliner plus et *department* i Professional and Intercultural Business Communication).

**Helsinki School of Economics** er en selvstændig business school, organiseret i 5 *departments* (klassiske business school discipliner plus et *dept.* of Languages and Communication).

**Universität St. Gallen** er en selvstændig business school, organiseret i fire *departments*: Dept. of Management, Dept. of Law, Dept. of Economics, Dept. of Humanities samt ca 30 *institutes*.

**HEC** er en selvstændig business school, organiseret i 9 *departments* (klassiske business school discipliner, incl. *Dept.* of Languages and Cultures) samt et antal bredere, tværdisciplinære forskningscentre.\*

**ESADE** er en selvstændig business school, organiseret i hvad der både omtales som *centres* og *faculties*: Escula Superior en Administración y Dirección de Empresas, the Law School, Summer School og Turismo Saint Ignasia.\*

**Bocconi** er en selvstændig business school, organiseret i 2 *departments*, der udgør den organisatoriske rygrad: the Department of Business Administration and the Department of Economics; samt i et netværk af *institutes* og *centres*, som udgør det forskningsmæssige afsæt.

**Wirtschaftsuniversität Wien** er en selvstændig business school organiseret i 12 *departments* og 11 *research institutes* (klassiske business school disciplines)

**University of Economics, Prague** er en selvstændig business school organiseret i 8 *faculties* (klassiske business school discipliner).

**Warsaw School of Economics** er en selvstændig business school organiseret i 5 *collegia* (klassiske business school discipliner).



**The Rotterdam School of Management** er en del af the Erasmus University Rotterdam, der er organiseret i følgende enheder: Erasmus School of Economics and Business Economics; Erasmus School of Law; Faculty of Social Sciences; Faculty of Philosophy, Faculty of History and Arts, Erasmus MC (Medicine), Institute of Health Policy and Management.

**University College Dublin** er et klassisk universitet med mange fakulteter (*colleges*). The Michael Smurfit Business School er en del af the College of Business & Law. Derudover er der College of Arts & Celtic Studies, College of Business & Law; College of Engineering, Mathematical & Physical Sciences, College of Human Sciences, College of Life Sciences.

**Corvinus University of Budapest** er et bredt funderet social/natural science universitet med i alt 8 *faculties*: Faculty of Business Administration, Faculty of Economics, Faculty of Social Sciences, Faculty of Public Administration, Faculty of Food Science, Faculty of Horticulture Science, Faculty Landscape Architecture, Protection and Development.

**Université Catholique de Louvain** er et klassisk universitet med hele spektret af fakulteter, herunder *Faculté des Sciences Économiques, Sociales et Politiques* og det tilhørende *Louvain School of Management*.

**Universitet zu Köln** er et klassisk universitet med hele spektret af fakulteter, herunder Faculty of Economic and Social Sciences, organiseret i tre *departments* (klassiske business discipliner plus en afdeling for tværdisciplinære aktiviteter).

### **\*Post scriptum:**

15. juni 2006 annoncerede to af de førende business schools i CEMS en ny strategisk alliance – jeg opfordrer til at nærlæse følgende:

ESADE and HEC, co-founders in 1989 of the CEMS\* Network, continue in 2006 to support the development of the CEMS both inside and outside of Europe. At the same time, they have now committed themselves to increase synergies between their two faculties and to further develop cooperation between programs.

**A strategic alliance encompassing all dimensions of the activities of the two schools:**

- Double-degree agreements for both MBA & and Master of Science of Management programs
- Joint faculty projects for teaching and research in key disciplines, such as strategy and governance, management control, logistics, innovation, management of art and culture, languages, human resource management, and finance and law
- Joint faculty recruitment and development
- Joint programs abroad (Latin America, Eastern Europe, Asia, and the Mediterranean zone)

Faculty interactivity will form the core of the alliance. Examples of already developed activity which will produce greater synergies are:

- The development of ten significant projects covering the breadth of all key management disciplines
- The “**Young Faculty Research Seminar,**” to encourage the interaction of recently recruited faculty members from both institutions. The second meeting of this group will be held June 16.

The alliance also includes an important joint new initiative - the creation of the “**ESADE-HEC CEO-Board Forum,**” an elite group of directors, CEOs and business experts from ESADE and HEC faculty – orientated towards the exchange of corporate experiences, joint research endeavors, and the formulation of educational proposals regarding Corporate Governance and Social Responsibility.

Finally, the alliance will be unique through a separate **collaboration agreement between the two alumni associations**, which when combined represent up to 50,000 graduates worldwide.
