CORPORATE PART-TIME MASTER MSc ECONOMICS & BUSINESS ADMINISTRATION (EBA)

Building bridges between business, students and CBS

What is a corporate part-time master in MSc EBA?

It is a four-year part-time program for students who are simultaneously engaged in part-time employment. The program meets the students and companies demand for more flexibility in the education system, increasing opportunities to combine a master's degree with relevant work.

Why is it a good idea?

It gives the student the necessary flexibility to organize a study program that takes into account the demand of being able to study concurrently with relevant work. The program can contribute with the latest academic knowledge to the company, while providing the student with important practical experience. Therefore, the link between work and study gives the opportunity to put the theoretical knowledge into play in a practical context. Simultaneously, the students are able to provide their employer with the latest academic knowledge, while observing its application in a practical setting.

What is the structure?

Overall, the corporate part-time master adheres to the same standards, and follows the same course structure and courses alongside the full-time MSc EBA program. This means that there are between 6-8 compulsory subjects (60 ECTS) divided over the first 2 years of the program, then 4 electives (30 ECTS) on the 3rd year, and the program concludes with a 30 ECTS Master's thesis on the 4th year.

What does the company commit to?

The corporate part-time master in MSc EBA requires an investment from all parties in terms of time, commitment, planning, and expectation management. The program is a learning process for the student, whose work assignments should require a bachelor degree and correspond to the student's skill-level throughout the four-year master program.

-An employment contract from the company with an average of 25 hours of work a week is required in for admission to the corporate part-time master.

-The company must also permit the student to attend classes and exams during daytime.

Salary and other work conditions are negotiated on an individual basis.
