

APPLICATION FORM – ADMISSION CARD (ASSESSMENT OF COMPETENCIES) FOR GRADUATE DIPLOMA PROGRAMMES

What is an assessment of competencies for the Graduate Diploma programmes?

If you do not fulfil the entry requirements for the Graduate Diploma, you still have a chance to get admission, **if you can document** that you through education/courses, work experience, voluntarily work etc. have achieved **competences** corresponding to the **entry requirements**.

What should I do?

- Fill out the **form** below.
- Find relevant **documentation for your competences** and add **appendix No**. Examples of documentation is a certificate of previous educations and/or courses, course descriptions, documentation for employment and work experience with a clear specification of responsibility- and work field or a description of voluntarily work. **Please be accurate with your documentation!**
- Attach your **résumé**, which should present a clear overview of your education background, work experience, voluntarily work etc.
- Send your application in **one PDF file** to the Admission Office of the Graduate Diploma hdtilmelding@cbs.dk.

How do I receive a response?

You will receive a letter with the decision of your application. A rejection will be well-founded. You can also get a conditional admission card, in which you are assigned to take one or more qualifying supplementary courses.

Cost of assessment?

It is free to obtain an admission card (assessment of competencies).
