SUMMARY

Len Seabrooke is Professor of International Political Economy and Economic Sociology in the Department of Organization at the Copenhagen Business School, and Research Professor at the Norwegian Institute of International Affairs. His work is known for its interdisciplinarity - drawing on political economy, economic sociology, international relations, and organization studies. Seabrooke's current research concentrates on transnational professionals across a range of cases, from finance and tax experts, to consultants, sustainability experts, and others. Seabrooke's work has appeared in leading journals, including American Sociological Review, Annual Review of Sociology, Contemporary Accounting Research, Governance, International Studies Quarterly, Journal of European Public Policy, Organization, Public Administration, Socio-Economic Review, Review of International Political Economy, and many others. According to Google Scholar, his work has been cited over 6200 times (h index 41, i index 73). He is an Associate Editor of Journal of Professions and Organization, and was a Co-Editor of Review of International Political Economy (2006-2012) and an Associate Editor of International Studies Quarterly (2014-2018). As Principal Investigator Seabrooke is a recipient of grants from the European Research Council (x2), European Commission (x3), Independent Research Fund Denmark, the Norwegian Research Council, the Velux Foundation, the Institute for New Economic Thinking and Transparency International-EU. He was the Chief Scientist of the ENLIGHTEN project (2015-2018) funded under the European Commission's Horizon 2020 program. Len currently co-leads a project for the Velux Foundation. Over his career Seabrooke has raised approximately €8,73 million as the named Principal Investigator and €33,29 million as co-author on research grants (over €42 million in total). He has a long history of institution building, particularly in research capacity, as well as the development of interdisciplinary teaching programs. Len is the Program Director of the International Business and Politics BSc. and MSc. degrees at the Copenhagen Business School and Chairperson of the Study Board. The BSc. IBP has consistently been ranked the third most difficult degree for undergraduates to enter across all sciences in Denmark. He is also the Chairperson for the Ethics Council at the Copenhagen Business School.
