The novel contribution of Susanne Boch Waldorff's dissertation is to extend the emerging literature on the heterogeneous institutional context, legitimizing accounts to the notion of translation [...]. This thesis also extends this work empirically with a very creative research design that includes both the field level of analysis (in the first paper) and the organizational level of analysis (the third paper). This is an important empirical/methodological contribution in that most prior work has focused exclusively on the field level or inter-organizational level and has largely ignored how processes of institutional change and interpretation occur at the intra-organizational level of analyses.
