As a PhD Fellow at Copenhagen Business School, I specialize in cross-sector social interactions (CSSIs) and partnerships in crisis and humanitarian contexts. My research investigates how spatial and institutional dynamics shape power relations, access, and legitimacy within local cross-sector efforts, particularly in disaster response and resilience. Grounded in critical geography and management studies, I adopt an interdisciplinary, qualitative approach to explore how local actors navigate and contest exclusionary governance structures across local, national, and international levels. My work contributes to broader debates on localization, private sector engagement, and inclusive governance in humanitarian aid and resilience efforts. Prior to my PhD, I worked with the World Food Programme and the UN's Connecting Business Initiative through the Mercator Fellowship on International Affairs, which deepened my interest in the operational and political challenges of cross-sector collaboration in crisis settings.
