CORPORATE MASTER PROGRAMME IN DIGITAL BUSINESS

Building bridges between business, students and CBS

What is a corporate master programme in Digital Business?

The corporate master programme ("erhvervskandidatuddannelse" in Danish) in Digital Business is a four-year part-time education programme for students who are simultaneously engaged in part-time employment. The programme is developed to meet an increasing industry demand for IT graduates who pos-sess a combination of technical skills, business understanding, and project management abilities.

Why is it a good idea?

Given the students in this programme are attending the university during their first years on the job market, the programme can develop courses that are in line with the newest digitalization developments. Simultaneously, the students are able to provide their employer with the latest academic knowledge, while observing its application in a practical setting.

What does the company get out of it?

Through daily interaction with the students, companies will acquire knowledge on theories and methods that is directly applicable to their use, optimization, and development of IT at strategic, tactical, and operational levels. The students will provide companies with new perspectives on the interaction between IT and business, as well as establish connections with research environments at CBS in the field of digitalization and business.

What is the structure?

Overall, the corporate master programme adheres to the same standards, and follows the same course structure, as the full-time MSc programme in Digital Business of which it is a part. The course content is grouped in three overall areas: business and leadership, business-relevant technical, and policy/law. In addition, the student will complete a number of practice-oriented projects in each of these aforementioned areas that will draw on the concrete tasks that the student works with every day. The programme concludes with the completion of a master thesis.

What does the company commit to?

The corporate master programme in Digital Business requires an investment from all parties in terms of time, commitment, plan-ning, and expectation management. The programme should be seen as a learning process for the student, whose work assignments should require a bachelor degree and correspond to the student's skill-level throughout the four-year master programme. An employment contract from the company with an average of 25 hours of work a week is required in order for a student to be admitted to the corporate master programme in Digital Business. The company should also permit the student to attend classes and exams during daytime. Salary and other work conditions are negotiated on an individual basis.
